## INTERVIEW HON. JUSTICE HANNATU SESSION WITH: AZUMI LAJA-BALOGUN JCA.

CLASFON NEWSLETTER: Good day Your Lordship. My name is Larayetan T. Sharon and I am from CLASFON Newsletter Editoriral Team. I am here on behalf of the Newsletter Editorial Team to have ask you a few Questions on this Interview Session if you oblige us Ma.

JUSTICE BALOGUN: You're welcome. You're most obliged. It will be a Pleasure.

CLASFON NEWSLETTER: Please may we meet you Ma.

JUSTICE BALOGUN: My name is HON. JUSTICE HANNATU AZUMI LAJA-BALOGUN. By Divine Privilege, I am a Justice of the Court of Appeal. I am a Christian and a CLASFONite.

CLASFON NEWSLETTER: As a founding member of CLASFON, what was the original vision behind establishing the Fellowship, and how well do you think it has been realized over the years?

JUSTICE BALOGUN: I was not one of the Founding Members of the Fellowship but I was a member before the very First Exco was elected and was part of the Constitution Drafting Committee.

The Original Vision of the Fellowship were:

a. To stop the Myth that one needs the Occult to succeed or function as a Lawyer or Judge.

b.To curb Corruption in Practice, e.g. Misuse of Client Funds, Sharp Practices etc.

The Visions of the Fellowship has been Partly realized. A lot of Lawyers and Judges have found better Security in Christ. The fear of God is the beginning of Wisdom. Prov. 1:7

CLASFON NEWSLETTER: How has your faith influenced your career as a judicial officer, and what challenges and success stories have you encountered in maintaining integrity on the Bench?

JUSTICE BALOGUN: My Faith has greatly influenced my career in several respects:

- \*God gives me Power to remain honest, shun bribes & try to be just.
- \*I want to please God & I know I am accountable to him and will be judged by him, so I work hard as unto him.
- \*My Faith helped me to put in my best even when promotion felt slow knowing that God is the one who decides where I should be and in what capacity I should serve.

CLASFON NEWSLETTER: Many young Christian lawyers look up to you as a mentor. What key values do you believe young legal professionals should uphold to succeed in law and remain rooted in Christ?

JUSTICE BALOGUN: The Key Values that I will admonish christian professionals to uphold are:

- \* Honesty and Integrity,
- \* Hardwork and Diligence,
- \* Patience Shun the Get Rich Quick Syndrome.
- \* Study Law Reports
- \* Maintain a close relationship with the LORD.
- \* Let pleasing God be top on the priorities list. \* Be obedient to God's word.
- \* be obegient to God 2 wor

\* Pray without ceasing.

CLASFON NEWSLETTER: With your experience on the Bench, what significant reforms would you like to see in Nigeria's judicial system to ensure greater efficiency, fairness, and justice?

JUSTICE BALOGUN: I would love to see more simplified procedures to ensure speedier Justice. Eg. Full computerization; Digital Proceedings etc. More Justices and Judges to be appointed and greater registry efficiency - more training; careful selection of court registry staff.

CLASFON NEWSLETTER: As a member of the CLASFON Board of Trustees, how do you see CLASFON shaping the future of the legal profession in Nigeria and beyond?

JUSTICE BALOGUN: CLASFON's role in shaping the Future of the Legal Profession in Nigeria cannot be overemphasized. They include:

More efforts to be put in in nurturing the Students Body because the Old Values are being lost.

CLASFON NEWSLETTER: As a distinguished female Justice, what advice do you have for young female lawyers aspiring to break barriers and rise to the highest levels in the legal profession?

JUSTICE BALOGUN: My Advice to young Female Lawyers include

- ▶Learn to balance Home and Work Life.
- ▶Employ Technology to save time.
- ►Talk to other Women who have passed the Child bearing/nurturing Stage.
- ►Don't quit going to court; you may need to work in less time demanding sectors when Children are young.

CLASFON NEWSLETTER: Having chaired the CLASFON Annual Grand Dinner at the 2024 CLASFON Students' National Conference in Port Harcourt, what were your key takeaways, and how do you think students can maximize such opportunities?

JUSTICE BALOGUN: About the Students' National Conference in Port Harcourt, I was impressed by the Huge Number of Delegates we had. There was obviously a mixed multitude "So the Parent Body has to pay closer attention". The Zeal of the Young People for the Things of God is Heart-Warming.

CLASFON NEWSLETTER: Looking ahead, what legacy do you hope to leave behind in the legal profession and CLASFON, and what message do you have for the next generation of Christian lawyers?

JUSTICE BALOGUN: LEGACY AND ASPIRATION:

- ▶That I served God faithfully in my Generation.
- A Legal Profession where Justice is more important than Riches.
- ► Where Lawyers on both sides help to achieve Justice based on Truth and the Law and not just to win their cases.

► Next Generation should keep their eyes on the goal which is to let Justice flow like a river by anchoring their Profession on Christ.

# "CLASFON, I CAME, I SERVED AND I AM BLESSED"-DR. CHUKWUMA A. J. CHINWO

In Chapter 4 of CLASFON: I Came, I Served, and I Am Blessed, titled "National Presidents", Dr. Chukwuma A. J. Chinwo unfolds the tapestry of leadership that has shaped the Christian Lawyers Fellowship of Nigeria (CLASFON) over the decades. More than a simple historical account, this chapter is a rich tribute to the men who, inspired by faith and driven by purpose, stewarded CLASFON through seasons of foundation-laying, consolidation, national influence, and internal transformation.

Each national administration, from the pioneering leadership of Dr. Wole Olufon to the energetic stewardship of Dr. Arome Moses Okwori, is presented with a blend of personal insight, institutional context, and spiritual reflection. Dr. Chinwo, writing not just as a historian but as a former President himself, captures the soul of the fellowship's leadership journey—one marked by vision, sacrifice, collaboration, and an unwavering devotion to Christ.

A Timeline of Divine Appointments

The list of national presidents and their respective general secretaries paints a picture of continuity and divine orchestration. From the earliest days when the fellowship was still gaining national structure, to the more recent years of organized administrative and spiritual expansion, each leader was seemingly appointed for a season and purpose.

Dr. Wole Olufon, for instance, not only served as the first National President but also temporarily doubled as the General Secretary—a testament to the sacrificial beginnings of the fellowship. He and others like Dr. George Ogunyomi laid a strong apostolic foundation that anchored CLASFON firmly on Christ.

Subsequent leaders built on this foundation, each bringing unique spiritual, legal, and leadership gifts. The intellectual depth of Prof. Bankole Sodipo, the political and administrative dexterity of Dr. Chinwoke Mbadinuju, the stabilizing role of Hon. Peter Jya, and the progressive foresight of Hon. Jonathan Kish Adamu all contributed to the evolving identity

of CLASFON as both a spiritual family and a professional movement.

Leadership with a Mission

One of the most moving themes of this chapter is the reminder that CLASFON's leadership has never been about titles, but about mission. Dr. Chinwo carefully documents how each administration confronted pressing spiritual and socio-political realities—be it advocating for the persecuted church, influencing the legal profession with godly values, or mentoring the next generation of Christian lawyers.

Many of the leaders served at great personal cost, managing the demands of full legal practice, family life, and national responsibilities within CLASFON. Yet, their commitment was not merely organizational—it was deeply spiritual. For them, CLASFON was not a career platform but a calling.

Faith, Administration, and Legacy

The chapter does not shy awav from recognizing the organizational evolution of CLASFON. highlights how It successive administrations improved on the fellowship's governance structure. communication with branches, strengthened the national secretariat. and expanded CLASFON's visibility within the Nigerian legal community.

Under various administrations, the fellowship became more involved in national discourse—holding public lectures, issuing position papers on issues of national concern, engaging with persecuted believers, and collaborating with other Christian bodies for kingdom advancement.

The review also touches on the growing involvement of women and youth in CLASFON's structure—signaling a maturing and inclusive fellowship prepared for generational succession.


Conclusion and Recommendation
